
## NODPC Meeting: Wednesday, May 4th, 2022

- 50-year anniversary for OHIO811
- Only 4 Executive Directors
  - Charles Gabriel (1972-1985) created mascot Bobby Backhoe and established OHIO811 as a Non-profit.
  - Charlie Lang (1985-1991) new location on Belmont Ave, Youngstown and established first 811 mapping center.
  - Greg Obsincs (1991-2005) hired first marketing director and established work from home program.
  - o Roger Lipscomb (2005-present) House Bill 458 in 2012 for communication/positive response and Senate Bill 378 in 2014.
- In the past year, big push for iDig and online services.
