Crucial Conversations -

- A discussion between two or more people where the stakes are high, opinions vary, emotions run high and the outcome greatly impacts their lives.
 - o How do we navigate the discussions to have mutual levels of understanding?
- Difficult conversations about performance
 - Have the conversation before it becomes an issue that is dealt with after a preventable incident.
 - Duck and Rabbit picture Try to understand that we can be in the same conversation and have different views. Just because the perception is different than yours does not mean its wrong. You must understand yourself to understand others to solve real problems.

DISC is Observable Human Behavior

D= Dominance () I= Influence (Joy) S=Steadiness (Non-emotion) C=Conscientiousness (Fear)

- o Know your coworkers or employees and the way to approach them the best.
- Be willing to listen first and talk less.
- Do not tell someone you know how they feel, you shouldn't feel that way, it will be ok, or they should feel a particular way. – We do not want to create self-doubt or confusion in someone.

Four levels of listening

- Zero Completely changes the subject S
- o subjective Listener relates to the listener.
- o <u>Objective</u> Listener is completely focus.
- o <u>Intuitive</u> Listening to voice, body language and energy not what is being said.

What to do!

 Acknowledge and validate what someone is saying. Normalize the feelings of a person instead of judging. Paraphrase what they are saying to acknowledge that you are listening and are trying to have the conversation.
